- the right to receive in a structured format of common use and clearly legible by automatic disposals (data portability according to Article 20 of GDPR);
- the right of object (Article 21 of the GDPR);
- the right not to be subjected to a decision based solely on automated processing, including profiling (automated decision-making process relating to natural persons) (Article 22 of the GDPR).

Exercise of Rights

To exercise your rights to the processing of your personal data, you can send a request to the email address privacy@ecolstudio.com

In the event of a request by the interested party for information relating to their data, the Data Controller must proceed without delay - unless it proves impossible or involves a disproportionate effort - and, in any case, at the most late within 1 month of receipt of the application. The deadline can be extended up to 3 months if necessary taking into account the complexity and number of requests received by the Data Controller. In such cases, the Data Controller within one month after receiving your request, he will inform you and make you aware of the reasons for the extension.

Complaint procedure

Without prejudice to any other administrative and judicial action, the interested party has the right to propose a complaint to the competent supervisory authority.
